

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.bigstarbranding.com, and Big Star Branding, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Big Star Branding, Inc. include www.bigstarbranding.com and Big Star Branding. The Big Star Branding website is a Promotional Products Catalog site. By using the Big Star Branding website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Big Star Branding may collect personally identifiable information, such as your:

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
